Changes

7 Terms and Conditions (Cont.)

Use of Equipment

The goods must be kept in good order and condition and be used according to the manufacturer's instructions. The goods must not be modified in any way without the prior written agreement of D4 Data Pty Ltd.

Rental Payments

Your renter's obligation to make rental payments under this agreement is unconditional and continues despite any breakdown, loss, theft or damage to the goods. If any rental payment or other payment is not made by the due date then interest shall be payable on each late payment at the rate of 2% per month calculated daily together with a late payment fee of \$ 5.00 for each late payment.

Renter to remain a franchisee of Poolwerx Corporation

In the event that the renter ceases to be a franchisee of Poolwerx Corporation Pty Ltd D4 Data shall have the right to assign this agreement to another Poolwerx franchisee. Or D4 Data shall have the right to require the return of the goods in good order and condition together with any outstanding payments under this agreement.

End of Term

At the end of this agreement the renter may either: -

- (a) Return all of the goods including the dongle provided with the software to D4 Data Pty Ltd in good order and condition. The renter must insure the goods while in transit to D4 Data Pty Ltd.
- (b) Continue to rent this equipment for an extended period at a revised rental agreed with D4 Data Pty Ltd.
- (c) Enter into a new rental agreement for such new upgraded goods as may be available at that time for a period and with a payment schedule agreed at that time.

Early Termination

At the condusion of an initial period of 12 months the renter can elect to terminate this agreement by :-

- (a) Providing 60 days notice in writing to D4 Data Pty Ltd of the intention to terminate this agreement.
- (b) Pay all payments due up to and including the termination date.
- (c) Return all of the goods including the dongle provided with the software to D4 Data Pty Ltd in good order and condition. The renter must insure the goods while in transit to D4 Data Pty Ltd.

Regular Service

During the period of this agreement D4 Data Pty Ltd agrees to provide, at no charge to the renter, service to the equipment consisting of cleaning the equipment and checking and adjusting the calibration of the equipment. The renter shall be liable for the cost of returning the equipment and for insuring the equipment during transit. The renter shall advise D4 Data when equipment has been dispatched for service. The renter will be liable for the cost of repairs, including labour parts and freight, that might be required by misuse or accidental damage to the equipment or as a result of failing to operate the equipment in accordance with the manufacturers instructions.

Configuration of Software

The software may be used to prepare treatment recommendations and otherwise manage swimming pools and spas under the supervision of the end user. The renter agrees to configure the software to meet the requirements of the end user and to ensure that the recommendations produced by the software comply with all relevant health regulations and engineering specifications

Software Upgrades

If the software is upgraded during the period of this agreement then D4 Data will either provide a copy of the upgraded software on a CD or other suitable media at no charge to the renter or make the upgraded software available for downloading from D4 Data's web site. D4 Data Pty Ltd will not be responsible for any costs incurred by the renter to install software upgrades.
